MARATHON COUNTY TREE PLANTER RENTAL AND OPERATION AGREEMENT:

Marathon County has two planters to rent. Circle the planter (below) you want to rent.

Planter #1: Hoses (on tractor-operated hydraulics planter-Yellow planter): There are hydraulic hoses with “pioneer” type ends which fits most tractors. I have a set of adaptors for John Deere tractors, contact me if you need to use them. Any other odd types will require you to take some ends off a piece of your own equipment or get adaptors to fit.

Planter #2 Motor (on self-contained hydraulics planter only-Orange planter): Works fine but it is noisy, stinky and has to be operated by the planter which makes things more stressful and difficult. The engine uses regular unleaded gas and 10W-30 oil. Check the oil frequently as it burns some and the machine doesn’t sit level all the time. Shut the gas off at the filter bowl when not running the engine. The hoses for the motor operation need to be hooked together when not being used or when towing.

COSTS: You must fill out this form and return it with your payment to get on list to use the planter.

I Agree to:

1. the terms and charges for use of the tree planter and to maintain the planter when I use it.
2. that it is allowed only for use on land which is being planted to trees or shrubs in Marathon County and is the land is suitable for machine planting.
3. reimburse Marathon County for use of the planter at the required rate before receiving the planter.
4. pay for any broken parts and labor caused from my misuse of the planter.
5. provide a suitable tractor with operator to pull the planter and manpower to plant the trees
6. purchase the trees and/or shrubs to be planted and pay any associated planting costs.
7. call **Bill Kolodziej** at Marathon County Land Conservation Department **715-261-6038** to report any problems, broken parts, issues with the planter and when the planter is finished being used by me.
8. not hold Marathon County or its agents liable for any such claims, loss, damage, injury and death, including all costs and expenses incurred from the rental of the tree planter or failure of trees to grow.
9. allow agents or employees of Marathon County to enter upon the premises of the lessee at any time to secure the return of the tree planting machine.
10. not allow the use of the planter by any parties other than myself, nor transport the planter to any other sites other than its original delivery site.
