## M.A.S.S. DESTINATION FORM

### The purpose of this form is:

- A. To identify which processing plant this animal is going to
- B. Provide contact information to the processing plant

All exhibitors must turn in the following forms to the on-site M.A.S.S. office (located in the locker room), within 60 minutes after hog judging is completed:

- a. "Destination Form" for extra animal(s) going to slaughter
- b. "Animal to be Sold" form

Per MASS rule F.5, failure to turn in these forms or turn them in on-time will:

- i. Authorize the Sale Chairman or designee to enter the top placing (ribbon) animal at the end of the sale order.
- ii. Require twenty (20) educational points the following year.

### To fill out this form:

- Use one form per animal.
- Provide the SAME information on Part A and Part B of this form. **DO NOT CUT FORM APART.** Part A will stay with the M.A.S.S. officials and will be used to assist with loading the animals onto the right trucks. Part B will go with the hauler to the processing plant.
